

#### WHO ARE WE?



Founded in 1999, under the Royal Patronage of Her Majesty Gyalyum Tshering Yangdön Wangchuck; the Royal Society for Protection and Care of Animals in Bhutan (RSPCA) is the first organization of its kind, fully dedicated for the welfare, protection and well-being of animals in Bhutan. RSPCA is registered as a Public Benefit Organization under the Civil Society Organizations Act of Bhutan 2007.

We work towards rescuing stray animals and providing them with care, stability, medical assistance and lifelong homes, while also solving the stray dog problems and reducing canine related diseases in order to maintain a healthy, safe and manageable stray dog population. Towards promoting the general welfare of animals by raising awareness through public education and campaign and sustaining the Animal Welfare Centre in Serbithang – the "House for the Downtrodden" for sick, injured and abandoned animals, which is now home to 87 dogs, 15 puppies, a calf and a bull and a mule.




Dr. Kinlay Dorji (Chief Veterinary Officer)

## "Building a Better World"

At more than 17 years old, our shelter has outlived its useful life. Although amazing work happens within its boundary, the small size of our facility prevents best practices that could save even more lives.



Our dream of a new shelter and a better world for animals would have remained a dream if not for the helping hand from Welttierschutzgesellschaft e.V. (WTG) Berlin, who is making our dream into a reality by funding our renovation plan.



## Programme Area 1.

#### **Animal Welfare Activities**

#### 1. Rescue and Treatment

- 98 rescues: 29 Puppies, 3 Cats, 64 Stray Dogs.
- Treatment and care
  - ✓ Scabies 52
  - ✓ De-worming 29 puppies
  - ✓ Calcium 18 puppies
  - ✓ Daily treatment 2 dogs
  - Dogs sterilized 11 dogs Sterilized.

Our team has rescued and treated 200 dogs and sterilized 11 dogs this year.

#### 2. House call for veterinary services

Aside rescues, the Society also initiated Veterinary Services, whereby we vaccinated 36 pets for rabies and kept track of vaccination requirement to ensure all vaccinations and follow up treatments are done in time.



The Society also took in house call, where by:

- 3 adoptees were vaccinated with anti-rabies and DHPPI
- 2 treated for wounds
- 1 for an eye infection

The team keeps a record of all treatments to ensure and follow up all vaccinations are done in time.





#### Some of our Rescue stories.

1. Just like others, he is one among many stray dogs in Thimphu rescued after a car ran over him a year ago and was found with his rare legs broken. His hope for survival was almost next to impossible but today it's a miracle for him as well for all of us to see him running & playing with his best friends (Momo, Katu & Mesha) and he is recovering fast. RSPCA expresses appreciation and thank you to each and every heroic life savers and animal life supporter across the country.



2. Our team has rescued a lactating stray with 13 puppies, (7males and 6 females) from Buddha Point. The stray mother with the puppies is homed in our shelter and all the puppies





were given Calcium drops and de-wormed. Currently the mother and all the Puppies are doing well in the shelter. Among those 13 puppies, a lucky one named "Ghost" got sponsored by Mr. Wiris William, a compassionate Animal lover outside Bhutan. We believe that all animals have the right to live as much as we do.

3. Another six Puppies were rescued from the way to BBS tower; Sangay gang. These puppies were cared and fed by a compassionate Animal lover Aum Tshewang C Rabgye

and her daughter for several weeks. She then called for RSPCA's help to rescue these puppies before they get hit by any car. Our team have rescued these puppies; they are de-wormed and housed in the shelter. These puppies will be sterilized when they turn 6months. However our team could not rescue their mother since it was difficult to catch them but our team is be - friending the mother dog including 6 other dogs (2 mothers, 2 male and 2 puppies) by daily feeding them.



#### 3. Sterilization Campaign.

In order to curb the ever increasing stray dog population, we ensure that all sick dogs at the shelter after they are treated from other diseases for which they are brought in are sterilized, vaccinated and dewormed Including rescued dogs, puppies and biting dogs that are rehabilited at the shelter. These dogs and other animals are sterilised and treated with the help of the team from the National Animal Hospital.





For this year 2018, eight dogs kept at the shelter were sterilized of which four were female and other four males. The dogs that underwent Sterilizations are all doing well and are back to their active self. Additionally three more stray dogs were sterilized with the help from local communities to catch these dogs.





#### 4. Animals Lover's Visit to the Shelter.



His Eminence Namkhai Nyingpo Rimpoche's visit to the shelter was a great honour for the RSPCA Family Our team including our sick dogs and office dogs were blessed to get blessing from His Eminence Namkhai Nyingpo Rimpoche. We believe that the blessing from His Eminence will definitely increase human-animal bond and connection.

Hon'ble minister, Ministry of Agriculture and Forest, Lyonpo Yeshey Penjor, visited our animals Shelter. He is the first minister to visit our animal shelter and it was a great honour for our Organisation that the Hon'ble Minister is willing to render support.





A youth group summit organized by a CSO called the Bhutan Centre for Media and Democracy visited the Shelter where they spent time with the animals and were very inquisitive about our work and programs. We also handed out our brochures, told them individual stories about the animals at the Shelter, and possible future plans. Many showed interest in volunteering for us in the future and even becoming members of the Society.

We also had a group of students from Royal Thimphu College Visiting the shelter. They were 5th semester students of Political Science and Sociology on their study tour to learn more about the Civil Society Organizations on its benefits and hurdles as a part of their project work and assignment. RSPCA is their first among many CSOs that they will be visiting.



#### 5. Mass cleaning campaign.



Students along with their teachers from Early Learning Centre School Visited the Shelter House for the Downtrodden to mark the Worlds Rabies Day. The students and teachers were actively involved in campus beautification, cleaning the shelter, Washing, Grooming shelter dogs and cooking meals for the dogs.













RSPCA team visits the Animal Welfare centre once every Month to clean the shelter. Following are some of the activities we do every month.

- 1. Cleaning the welfare centre
- 2. Cooking meal for the animals
- 3. Washing dishes and food bowls
- 4. Feeding treats and meals
- 5. Grooming the dogs











## Programme Area 2.

#### Advocacy and awareness programme in the Schools.

#### 1. Awareness activity on animal Welfare.

The year 2018 has been an active year for RSPCA team having interactive sessions with schools and colleges in Thimphu, South Bhutan (Phuentsholing and Gedu) and schools in Eastern Bhutan (Pemagatshel and SamdrupJongkhar) working towards creating awareness on animal maltreatment and canine related diseases, Awareness on responsible pet ownership, Waste management and inculcating a sense of moral responsibility by forming Animals lovers club in the Schools and colleges.

### a. Advocacy in Thimphu Schools

RSPCA visited the following schools and set up an Animal Lovers Club:

- Thimphu Primary School
- ELC Junior





The team met with two groups of very enthusiastic students, a total of 75 students who are extremely passionate about animal welfare in particular and social responsibility in general. Our team did short presentation on our organization, programs and activities, how to register etc and distributed brochures and forms (Membership, Adoption, Sponsorship and Foster).

The response from the children were amazing, they had great ideas and suggestions which are definitely going down in our activities list.

RSPCA in collaboration with Jangsa Animal Saving Trust and National Veterinary Hospital visited five Primary Schools in Thimphu to Advocate on Animal Welfare and awareness on stray dog bites and Sterilization. The Program started with a Welcome song and was followed by various Theatre acts on;

- 1) The signs that stray dogs show before biting
- 2) Reasons why stray dogs bite
- 3) Five types of risky dogs
- 4) The importance of sterilization and
  - 5) Community Ownership







#### 2. Advocacy tour to South and Eastern Bhutan

RSPCA team headed by Executive Director started advocacy tour from the 16<sup>th</sup> of September 2018 along with a team of volunteers to advocate against animal maltreatment, canine related diseases and with the aim to form an animal lovers club in 8 schools and 2 colleges in Pemagatshel, Samdrup Jongkhar and Chukha Districts. #### COLLECTIONS OF DONATED MATERIALS.

#### a. Fire woods



The food for more than 96 dogs and two bulls at the shelter is prepared by the caretaker *Aum Lhamo* with fire woods. These fire woods we receive are from construction sites, saw Mills, and from the residents in Thimphu. This year our team have collected four Boleros and one DCM trip of fire woods from Jungsina Construction site and Changzamtog Nissan Show room.

#### b. Hay collection







A compassionate Animal Lover from Punakha has donated rice straws to use as a matt for the dogs and protect them from the cold winter months. It was not only used as a mat by the dogs but the taste of it was also enjoyed by our two bulls at the shelter.

## Programme Area 2.

## **Our Shelter Programme.**

The Society also started the following programs which encouraged people of all age to participate and volunteer:

#### 1. BUDDIES PROGRAM

In RSPCA "Buddies program", we take the children for a tour of our shelter. The dogs clearly love it. This helps the children learn about the value of life and to develop mutual love and trust. The team ensures the safety of both kids and the animals. Besides young children, we also have residents and tourists join us for the program.





#### 2. MEMBERSHIP

Members enjoy many benefits, including a subscription to our half yearly newsletter and the opportunity to visit our shelter any time of the year. In addition, we keep you informed of RSPCA's progress with special mailings as well as an annual report. Our membership charges are as follows;

- Adult Nu 750
- Students Nu 250
- Tourist \$25

The Society recruited a total of 104 members till date from all walks of life: Students, Civil servants and residents.



#### 3. FOSTERING

Foster a pet! Every year we need dozens of foster homes to help raise litters of puppies and kittens. We also need foster homes to help socialize dogs so that they can become great pets for adopters. "Baby" is our first fostered dog. A resident from Thimphu came forward to give "Baby" a home to care, love and attention for 10 days.



#### 4. ADOPTION

For people interested in adoption, we have "Meet and greet" session, where we guide the interested visitors around the shelter, have them interact with the dogs, give them treats and see if they feel a bond with anyone in particular. The interested adopter then fills out an adoption form and is free to take home a lifelong companion. RSPCA ensures the adopted pets are vaccinated against Rabies, de-wormed and given DHPPI vaccine Free of cost for one year.

#### 5. SPONSORSHIP.

Sponsorship is for people who wants to help but are unable to foster or volunteer. The sponsor can visit our shelter and personally pick a dog. We send a monthly update on how your furry friend is doing. Aside sponsoring an animal, you can also sponsor small projects at the shelter like upgrading the kennel and improving the physical environment of the shelter. #### 6. VOLUNTEERING

Volunteering activities includes:

- Transport animals from shelters, foster homes or veterinarian appointment
- Help with administrative tasks
- Help with fundraising drives and campaigns
- Collection of waste food from hotels and restaurant
- Grooming
- Maintenance/Up keeping: Wash bowls, clean visitors area, kennels etc
- Assist adoption events or help our team with event coordination
- Help with fun special events such as Buddies program

- Be an outreach ambassador to spread our mission in the community
- Become a foster parent and take needy animals to your home for Specialized care
- Help physically and mentally stimulate the pets in our care.
